## Who can activate the membership?

Players registered with clubs other than the Circolo Golf Bogliaco, if in possession of a FIG card or another international federation.

## When to renew or activate the membership?

By 31 January 2024

## GENERAL CONDITIONS AND METHOD OF USE OF BENEFITS

### Subscription

- The Member Card is personal. The subscriptions and services purchased are valid from 1 January 2024 until 31 December 2024.
- The possibility of passing from one formula to another during the year is not envisaged and must be evaluated with the Management, with an integration to be defined at the time of the application.
- To sign up, it is mandatory to present the card of the Club to which you are registered. First Circle association must be on at least 9-hole courses and of "full" type (ordinary or midweek).
- Members not registered with the F.I.G. are not admitted. or international federations, members of "aggregate" associations or "virtual fields" (e.g.: Mia, Tourist Golf, Green Pass, Break Point), or members of any field not approved by the FIG. or by international federations.
- The fees in the agreement do not apply to those who have been a member of Golf Bogliaco in the previous 5 years (except in special cases at the discretion of the Golf Bogliaco Management). However, the Management of Golf Bogliaco reserves the right to limit access to these formulas.

### Services

- The services, for which a reservation is required, are subject to availability.
- Discounts and concessions are applied only if the subscriber makes the payment. They cannot be combined with other ongoing promotions and are not valid for online purchases. In the presence of more advantageous promotions, compared to the discounts reserved, the most favorable rate will always be applied.
- The discount percentages will be calculated on the list rates (gross of VAT) which may undergo changes or updates during the year.

## INFORMATION ON THE PROCESSING OF PERSONAL DATA

Dear Sir / Dear Madame,

pursuant to current legislation on the protection of personal data, we inform you that your personal data will be collected and processed using manual and IT tools for the following purposes:

The provision of personal data for the purposes in lett. a) it is mandatory and the refusal to provide such data makes it impossible to establish and implement the relationships in question. The relative treatment does not require the consent of the interested party.

With reference to the purpose referred to in lett. b), subject to explicit consent, the personal data provided will be communicated to TERME DI SIRMIONE S.p.A., a company to which Golf Bogliaco S.r.l. is affiliated, which will use them to send you (also by means of automated tools such as e-mail, sms, mms) commercial proposals and communications relating to services and/or products that it offers (by example, services of accommodation facilities, spa products, etc. Personal data are kept for times strictly functional to the pursuit of the stated purposes and to ensure the customer the best support on the occasion of his subsequent visits to the facility. For the treatments referred to in purposes b) and c), the data will be kept until revocation of the consent. With reference to purpose c), the data will be kept for 24 months. The achievement of the aforementioned purposes may also take place by means of transmission and communication of data to third parties, by this meaning such third parties authorized to the correlated processing of the data themselves, as they are responsible for carrying out or providing specific services strictly functional to the execution of the contractual relationship. We remind you that as an interested party you have the right to ask the data controller to access your personal data and to correct or cancel them or limit their treatment or to oppose their treatment. As an interested party, you also have the right to withdraw the consent at any time without prejudice to the lawfulness of the processing based on the consent given before the revocation and the right to lodge a complaint with a supervisory authority.
